Lewis Family Farm (LFF) is located in upstate New York. The LFF is certified to the USDA National Organic Program (NOP) by NOFA-NY and is currently in good standing with NOFA-NY. LFF is currently certified organic for both crops and livestock; and the Organic System Plan was in place and being followed by the employees of the farm.

The farm consists of approximately 1200 acres of crops and pasture along with approximately 130 head of breeding cows and 68 calves at side with 25 steers being fed out from last year's crop of calves. All animals are on continuous pasture feeding during the growing season of the pastures which is usually May–December. In the winter months, the animals are all fed baled hay in the "timber" portion of the farm.

The crop portion of the farm consists of different blends of grasses and alfalfa. LFF currently has approximately 3200 bales of home raised hay and LFF has purchased an additional 500 bales of organic hay for a reserve stock. All animals were observed on the hay/pasture fields and had not been fed any hay as of the audit date. Records reviewed showed the amount of hay harvested from the farm and stored on the farm plus the amount of hay bought this summer/fall. Records showed that all wheat that was remaining on the farm from previous harvests had been sold to another organic producer and the actual grain bins to hold any grains had been sold and removed from the farm. Records reviewed also verified that LFF is keeping the log of hay inventories and also the amount of hay fed to the animals on a weekly basis to show consumption of hay. The only other consumables the livestock receive are salt and a mineral mix that does not contain grain(s).

Records are either kept in hard copy and/or entered into the computer. Identification of the livestock is done by EID tags applied to the calf within 72 hours of birth. Records reviewed verified all present and past calves as well as mother cows born on the property. The 25 steers from the 2011 calf crop and the 68 head of calves from the 2012 crop were verified to have only consumed pasture grasses/hay and baled hay during the past winter.

Interviews with the day to day farm manager confirmed the farming and feeding techniques used and followed to ensure that the calves are indeed only grass fed.

#### **FINDINGS**

Observations made, interviews conducted, and records reviewed verified that LFF is in conformances to the requirements of the audit criteria. The corrective actions for the non-conformances identified during the previous audit were verified as being implemented and effective and the past non-conformance is cleared. There were no non-conformances identified during the audit.

#### RECOMMENDATIONS

Based on the audit findings, the auditor recommends that the Lewis Family Farm continue to be approved for meeting the USDA Grass Fed Marketing Claim and that LFF continue to be listed on the USDA Program website for Verified Operations.

#### NOTIFICATION OF AUDIT RESULTS

The Grading and Verification Division has reviewed the results of the surveillance audit of the Lewis Family Farm Verified Operations Program for the USDA Grass Fed Marketing Claim.
